Title: Facilities & Maintenance Technician

**Department: Facilities** 

Reports to: Safety and Facilities Manager Status: Hourly, Non-exempt, Full time

## **General Description**

Under the supervision of the Safety & Facilities Manager [SFM] the Facilities & Maintenance Technician inspects, repairs, and maintains various equipment and infrastructure for the organization. The Technician responds to assigned work orders and sees them through to completion, utilizing the most efficient and cost effective methods for repair and maintenance. The Technician plays a key role in ensuring the facility is audit ready at all times.

## **Essential Duties and Responsibilities** include the following. Other duties may be assigned.

- Performs regular preventive maintenance on machines, equipment and facilities.
- Performs minor electrical maintenance to include but not be limited to replacement or repair of fixtures (e.g. wall switches and outlets, incandescent and fluorescent bulbs and tubes, ballast, sockets, fuses, minor appliances, cords, etc.) using appropriate hand, power and specialty tools.
- Performs minor plumbing maintenance (e.g. replacement or repair of leaks in drains and faucets, unclogging of drains, trenching and laying new lines, replacing drain hoses on washers and similar devices, etc.).
- Performs minor painting, carpentry and masonry work (e.g. preparing surfaces and using brush, sprayer, or roller to apply paints, stains, and varnishes, hanging doors, fitting locks and handles, etc.).
- Reconfigures, installs, positions, and remounts modular offices and space (e.g. furniture, wall panels, work surfaces, storage bins, lighting, file cabinets, etc.)
- Prepares surfaces and paints various structures and equipment (e.g. walls, refrigerators, evaporative coolers, floors, roofs, doors, restroom facilities, etc.) to preserve wood and metal parts from corrosion and maintain a safe, comfortable working environment using various painting equipment and related tools (e.g. sprayers, rollers, brushes, thinners, etc.).
- Assists with emergency/unscheduled repairs of production equipment and performs scheduled maintenance repairs of production equipment during machine service.
- Complies with safety regulations and maintains clean and orderly work areas. Reports safety concerns to SFM immediately.
- Orders parts and coordinates with 3<sup>rd</sup> party vendors when necessary
- Completes and maintains various safety & facilities logs as required by internal policies and procedures as well as auditing agencies
- Works in collaboration with the SFM and other departments to ensure the facility is audit ready at all times
- Keeps supplies and equipment organized and ensures they are in proper working order
- Assist with event & conference room set up and break down
- Cleans rooms, hallways, lobbies, lounges, rest rooms, corridors, elevators, stairways, parking lots, and other work areas. Assists with custodial duties as needed.
- Performs other work related duties as assigned.
- Must be able to work flexible hours.

### **Minimum Qualifications**

- High school diploma or GED, or equivalent combination of education and experience
- 1+ years facilities/maintenance experience
- 1 + years hands on experience working with plumbing, carpentry and HVAC
- Ability to troubleshoot electrical, mechanical and pneumatic systems, desired
- Knowledge of warehousing safety and sanitary standards
- Forklift knowledge and experience preferred
- Valid NYS Driver's license
- Basic computer skills
- Able to work in a team environment and work independently
- Able to communicate clearly and concisely orally and in writing
- Able to apply basic mathematical concepts
- Detail orientation and organization skills
- Willingness to work in varying weather conditions and on a flexible schedule as needed
- Able to lift and carry materials and equipment weighing up to 60 pounds on a frequent basis.
- Friendly, customer-oriented personality
- Fluency in English required. Knowledge of Spanish helpful

# **Physical Demands**

While performing the duties of this job, the employee is regularly required to sit and talk or hear. The employee is required to use hands to handle or feel items such as documents and equipment. The job requires repetitive movements like bending, crouching, kneeling, lifting and carrying materials and equipment weighing up to 60 pounds.
