

# Application Process



## Completed Application packets include:

1. The application
2. Nomination form
3. Recent Physical (within the last year )
4. Picture identification (NYS Non-driver I.D., Driver's License or Passport)
5. Social security card (We will make copies of ID and SS card)

A committee reviews all applications carefully. During this pre-screening process, candidates are selected to come in for an initial interview with a team of Foodlink staff. Candidates should bring supporting documents including recent resume, certificates and/or diplomas, copy of HSD, GED or TASC, and letters of personal reference. During the interview, candidates also will sit for a literacy & math assessment.

Candidates who successfully complete the initial interview are scheduled for a 1 to 2-shift pre-training shadow in the kitchen, followed by a drug screen. Candidates will work in various food-production stations, cook for our chefs, and will be evaluated on the following criteria:

- Punctuality
- Ability to follow instructions
- Sense of urgency
- Ability to multitask
- Teamwork
- Attitude
- Ability to focus

All candidates are contacted directly to provide constructive feedback at this stage of the process. Candidates are accepted into the Fellowship and advised of their orientation schedule upon successfully completing the shadow days and passing the drug screening.

---

The Foodlink Career Fellowship selects 14 candidates per cohort and places 3 on the waiting list. After the training program start date, there is a 2-week assessment period, in which candidates may withdraw or be asked to reapply. This is also a time for instructors to assess participants on their performance. During this period, wait-listed applicants may be enrolled to fill those spots within the first 10 days of the program.

The wait-list selection process is determined by the applicant most qualified to pick up and catch up 10 days into the program.

# Eligibility Criteria

The Foodlink Career Fellowship is designed to support individuals who have faced significant barriers to sustained employment and career growth. This is a competitive training program and each candidate undergoes a rigorous assessment prior to acceptance. Successful applicants must meet the following eligibility criteria:

#### **The Basics**

- At least 18 years of age
- Able to be in class from 7 am to 4 pm, Monday through Friday.
- Eligible to work in the United States
- Curious, ready to learn, and able to complete all homework assignments
- Drug free (a minimum of 60 days sobriety)
- Lives in a stable housing environment
- Home for at least one month after incarceration, and clear of any arrest warrants
- Able to read, speak, and comprehend English in a fast-paced environment

#### **Physical requirements**

- Have a current physical exam (within a year of application date)
- Able to see well enough to read at 2.5 feet with reasonable accommodations
- Able to stand for a minimum of 8 hours with two 10-minute breaks and be able to lift 50 pounds with reasonable accommodations
- Able to hear in an environment with background noise from a distance of 20 feet with reasonable accommodations

#### **Competencies**

- A high school diploma or TASC degree is not required, however all applicants must complete a TABE with a minimum 6th grade reading and writing levels
- Successfully complete the hands-on, pre-training shadow and evaluation
